

Bionic Terms of Service

Welcome to Bionic. By using our products and services, you agree to the following terms. If you do not agree, do not use our services.

1. License and Ownership

- All products, including but not limited to bots, software, and services, remain the property of Bionic.
- Customers are granted a non-transferable, revocable license to use our products under these terms.
- Any attempt to claim ownership of our products is a direct violation of this agreement.

2. Prohibited Actions Engaging in any of the following actions will result in temporary or permanent revocation of your license, and may lead to legal consequences:

- Tampering with Bionic products in any way, including modifying, reverse-engineering, or altering their functionality.
- Obfuscation Bypass: Attempting to decompile or bypass obfuscation of our bot's code.
- Token Resets: Resetting your bot token to disrupt our services.
- Malicious Practices: Using our products for illegal or unethical activities, including scams, fraud, or spreading malware.
- DDoS Attacks: Attempting to disrupt Bionic services through denial-of-service attacks.
- Raiding and Harassment: Organizing or participating in attacks against our servers, bots, or communities.
- Unauthorized Sharing: Leaking, distributing, or sharing your bot with servers or users who do not own the license is strictly prohibited and will result in immediate license revocation.

3. Service Control and Restrictions

- Bionic retains full control over hosted products, including the ability to suspend, terminate, or modify any service at any time.
- Customers acknowledge that they do not own their assigned bot or service, but instead, have a license to use it while complying with our terms.
- Any attempt to take control of a bot or unauthorized modifications will be met with serious consequences, including possible legal action.

4. Bot Authorization and Public/Private Settings

- Adding the bot should only redirect you to [https://bionic.wowzatm.me/authorize/\[YOUR_USER/COMPANY/ENTITY\]/\[BOT_TYPE\]](https://bionic.wowzatm.me/authorize/[YOUR_USER/COMPANY/ENTITY]/[BOT_TYPE]). If it redirects anywhere else, this could be a false sign.
- Users can toggle whether their bot is public (allowing anyone to add it) or private (requiring a manual OAuth link request for adding).

5. Enforcement and Legal Action

- Bionic reserves the right to terminate access to services without refund if a user is found violating these terms.
- Legal action will be pursued if tampering, fraud, or attacks on Bionic's services result in financial or reputational damage.
- Cooperation with law enforcement may be provided in severe cases.

6. Additional Terms and Agreements

- By using Bionic services, you are also bound by the WowzaTM and Eclipse Terms of Service.
- Users agree to comply with WowzaTM's general terms, as Bionic is jointly owned by WowzaTM and Eclipse.
- Any violation of these additional terms may result in suspension or permanent termination of services.
